INSURANCE RENEWAL

To ensure our Insurance Brokers have enough time to source the best price for our insurance cover the due date for payment **is 17th August 2018.**

For the first time in 5 years the premiums have gone up this year. This is unfortunate but it is still the cheapest policy available that is suitable for our purposes.

Victorian Quilters Inc. is charged an additional cost for each Group added to the policies after the due date. This cost plus the Insurance Package cost will be charged on to the individual groups if their applications are received after the 17th August.

VICTORIAN QUILTERS INSURANCE PACKAGE

Public Liability

As we are 'Member' Groups, i.e the Members 'own' the Group, Public Liability Insurance does not cover accidents to Members. You cannot 'sue' yourself. It is imperative that groups have Public Liability Insurance for hiring of venues and is usually a condition of hire

Personal Accident Policy

This covers all Members/voluntary workers whilst engaged in voluntary work authorized and under the control of Victorian Quilters Inc. This policy is not a complete re-imburement but will help with costs should an accident occur.

Directors/Officers Liability – Association Liability

This is to cover Committee Members of the association -

It covers professional liability for services provided to members as well as the general public e.g. for claims that do not involve bodily injury or property damage or for claims made by or against volunteers of the association

The rates are as follows:

1 – 25 Members	\$95.00
26 – 50 Members	\$140.00
51 – 100 Members	\$250.00
101 – 200 Members	\$380.00
201 – 300 Members	\$430.00
301 – 400 Members	\$510.00
401 & over Members	\$560.00

If you wish to be part of the Victorian Quilters Package, please insert premium amount applicable to your number of members, you must be accurate, on the remittance form to add to your Membership Renewal amount. **YOU MUST BE A CURRENT GROUP MEMBER TO BE COVERED BY THE INSURANCE.**

A 'Certificate of Currency' is only required if requested by Landlords for hire of Venues, however a copy will be sent to your Group at the end of September. Exhibitions Cover

This is a limited cover for the quilts whilst in transit and at an Exhibition from theft and fire, from a securely locked premises, when left unattended. This also covers quilts left at the homes of 'collection/drop off points'. It is not economically viable to have insurance for 'shoplifting' i.e. quilts taken from the premises during put up/take down and Exhibition open times.
